THE CONSTITUTION OF THE FLORIDA TWO-YEAR COLLEGE MATHEMATICS ASSOCIATION

Revised: OCTOBER 1, 1996

Article 1 – Name

The name of the association is the Florida Two-Year College Mathematics Association.

Article 2 – Purpose

The Florida Two-Year Mathematics Association is a nonprofit, education association. The purpose is:

- a. to encourage the development of effective mathematics programs;
- b. to afford a state forum for interchange of ideas;
- c. to further develop and improve the mathematics education and the mathematics-related experiences of students in two-year colleges;
- d. to promote the professional welfare and development of its members.

Article 3 – Membership

Any person interested in two-year college mathematics education is eligible for regular membership.

Article 4 – Dues

Dues are paid by all members at the designated rates set at the Annual Meeting.

Article 5 – Officers

The officers of the Association are President, President-Elect, Past President, Vice President-Programs, Secretary, Newsletter Editor, and Treasurer. Each serves for a term of two years. The President-Elect automatically succeeds the President at the end of the President's term. The affairs of the Association are conducted by the officers of the Association, called the Executive Board, subject to the authority of the membership. In the event that an officer other than the President leaves office before the expiration of the regular term, the Executive Board shall appoint a replacement for the remainder of the term. Should the President leave office before the expiration of the regular term, the President-Elect will complete the unfinished term in addition to his/her regular term.

Article 6 – Meetings

The Association shall hold one regular business meeting, which is designated the Annual Meeting, each year. The Annual Meeting will normally be held in conjunction with the MAA-FL section Annual Meeting each spring. Additional meetings may be planned at the discretion of the Executive Board.

Article 7 – Elections

Officers are elected by regular members using the procedures outlined in the By-Laws. New officers start their term immediately following the Annual Meeting after each election.

Article 8 – Committees

Committees are created as needed by the Executive Board to carry out the purpose of the Association. These committees are dissolved, when appropriate, by the Executive Board.

THE CONSTITUTION OF THE FLORIDA TWO-YEAR COLLEGE MATHEMATICS ASSOCIATION

Revised: October 2, 2009

Article 1 – Name

The name of the association is the Florida Two-Year College Mathematics Association.

Article 2 – Purpose

The Florida Two-Year Mathematics Association is a nonprofit, education association. The purpose is:

- a. to encourage the development of effective mathematics programs;
- b. to afford a state-wide forum for interchange of ideas;
- c. to further develop and improve the mathematics education and the mathematics-related experiences of students in the first two years of college;
- d. to promote the professional welfare and development of its members.

Article 3 – Membership

Any person interested in mathematics education in the first two years of college is eligible for regular membership.

Article 4 – Dues

Dues are paid by all members at the designated rates set at the Annual Meeting.

Article 5 – Officers

The officers of the Association are President, President-Elect, Past President, Vice President-Programs, Secretary, Treasurer, Newsletter Editor, Webmaster, and Membership Services Coordinator. Each serves for a term of two years. The President-Elect automatically succeeds the President at the end of the President's term. The affairs of the Association are conducted by the officers of the Association, called the Executive Board, subject to the authority of the membership. In the event that an officer other than the President leaves office before the expiration of the regular term, a replacement shall be appointed by the President with the approval of the Executive Board. Should the President leave office before the expiration of the regular term, the President-Elect will complete the unfinished term in addition to his/her regular term. A quorum is defined as two-thirds of the Executive Board.

Article 6 – Meetings

The Association shall hold one regular business meeting, which is designated the Annual Meeting, each year. The Annual Meeting will normally be held in conjunction with the MAA-FL section Annual Meeting each spring. The membership shall be notified at least three months prior to any changes to the date of this meeting. Additional meetings may be planned at the discretion of the Executive Board.

Article 7 – Elections

Officers are elected by regular members using the procedures outlined in the By-Laws. New officers start their term immediately following the Annual Meeting after each election.

Article 8 – Committees

Committees are created as needed by the Executive Board to carry out the purpose of the Association. These committees are dissolved, when appropriate, by the Executive Board.

Article 9 – Governing Rules

The rules contained in Robert’s Rules of Order, Revised, govern in all cases to which they are applicable and in which they are not inconsistent with this Constitution or By-Laws.

Article 10 – Amendment Procedure

Proposed amendments to this Constitution are initiated by a majority vote to the total annual Assembly in the spring. Ratification of a proposed amendment is conducted by a mail ballot of all members. A two-thirds vote of approval of the members responding by the deadline stated on the ballot is required for ratification. Ballots will be prepared, distributed, and tallied under the direction of the Executive Board or its delegate(s).

Article 11 – Affiliations

The Association shall be affiliated with the American Mathematical Association of Two-Year Colleges, the Florida Council of Teachers of Mathematics, the Florida Section of the Mathematical Association of America, and the National Council of Teachers of Mathematics.

Article 12 – Dissolution

The Association may be dissolved only after an amendment of this Constitution has been adopted that provides for the transfer of all unencumbered funds to an organization with similar purposes.

Article 13 – Adoption

This constitution shall be adopted when approved by the majority of the interested people attending the Spring, 1997 meeting.

BY-LAWS OF THE FLORIDA TWO-YEAR COLLEGE MATHEMATICS ASSOCIATION

Revised: OCTOBER 1, 1996

Article 1 – Membership

Any person becomes a member upon filling out the membership form and paying dues for the current membership year. The membership year shall begin January 1 each year. Only members of the Association may hold office, nominate candidates for office, nominate candidates for awards, receive awards, or serve on official committees.

Article 2 – Duties of Officers

The President shall:

- preside at all meetings of the association, serve as Chairman of the Executive Board, and prepare the agenda for all Assembly and Board meetings.
- act as ex-officio member of all committees.
- Appoint one of the members of the Executive Board to serve in he/her place in case of temporary absence.
- organize and coordinate the program of the regular business meetings.
- accept nominations and make appointments of delegates to the national convention of AMATYC and when applicable, NCTM.
- take charge of publicity, public relations, membership.
- perform all other duties that regularly pertain to the office.

The President-Elect shall:

- serve as a voting member of the Executive board.
- serve as Chair of the Nominating Committee.

Article 9 – Governing Rules

The rules contained in Robert’s Rules of Order, Revised, govern in all cases to which they are applicable and in which they are not inconsistent with this Constitution or By-Laws.

Article 10 – Amendment Procedure

Proposed amendments to this Constitution are presented by the membership and initiated by the Executive Board. The proposed amendments are then communicated to the membership at the Annual Meeting and in the newsletter or other official means of communication. Ratification shall require a two-thirds vote of approval by members in attendance at the subsequent Annual Meeting.

Article 11 – Affiliations

The Association shall be affiliated with the American Mathematical Association of Two-Year Colleges, the Florida Council of Teachers of Mathematics, the Florida Section of the Mathematical Association of America, the Florida Developmental Education Association, and the National Council of Teachers of Mathematics.

Article 12 – Dissolution

The Association may be dissolved only after an amendment of this Constitution has been adopted that provides for the transfer of all unencumbered funds to an organization with similar purposes.

Article 13 – Adoption

This constitution shall be adopted when approved by the majority of the interested people attending the Spring, 1997 meeting.

Amendment 1 – Review Process

The constitution and by-laws shall be reviewed by the Executive Board every six years beginning in 2010.

BY-LAWS OF THE FLORIDA TWO-YEAR COLLEGE MATHEMATICS ASSOCIATION

Revised: October 2, 2009

Article 1 – Membership

Annual Membership

Any person becomes an annual member upon filling out the membership form and paying dues for the current membership year. The membership year shall begin July 1 each year. Only members of the Association may hold office, nominate candidates for office, nominate candidates for awards, receive awards, or serve on official committees.

Lifetime Membership

Any person becomes a lifetime member upon filling out the membership form and paying fifteen times the annual membership dues.

Article 2 – Duties of Officers

The President shall:

- preside at all meetings of the association, serve as Chairman of the Executive Board, and prepare the agenda for all Assembly and Board meetings.
- act as ex-officio member of all committees.
- Appoint one of the members of the Executive Board to serve in he/her place in case of temporary absence.
- organize and coordinate the program of the regular business meetings.
- accept nominations and make appointments of delegates to the AMATYC Annual Conference and when applicable, NCTM.
- take charge of publicity, public relations, membership.
- perform all other duties that regularly pertain to the office.

The Past President shall:

a. serve as a member of the Executive Board.

b. serve as a member of the Nomination Committee

The Vice President-Programs shall:

a. be in charge of the FTYCMA portion of the Annual Meeting

b. serve as a voting member of the Executive Board.

c. Serve as a member of the Nominating Committee.

The Newsletter Editor shall:

a. create and distribute at least one edition of a newsletter each year.

b. notify members of Association meetings through the newsletter.

The Secretary shall:

a. be responsible for the official correspondence to the Association.

b. keep accurate permanent records of meetings of the Association and the Executive Board.

The Treasurer shall:

a. be in charge of records and funds of the Association.

b. be in charge of all receipts and disbursements of the Association and keep accurate records of the same.

c. make a financial report at each regular business meeting.

d. make an annual report, audited by a supervisory committee at the regular meeting.

e. keep an up-to-date file and mailing list of members and potential members.

Article 3 – Election Procedures

The nominating committee shall consist of the President-Elect (chair), the Past President, and two members appointed by the current President. The nominating committee shall select a slate of nominees for each office. Anyone desiring nomination for an office shall notify the Chair of the nominating committee in writing by mail and present to the chair a brief biographical sketch at least three months prior to the Annual Meeting. The election will take place at the Annual Meeting. After taking nominations from the floor, a vote will be called for each office. The nominee receiving the plurality of voter from members present will be elected to office.

Article 4 – Amendment of the By-Laws

Amendments to the By-Laws may be proposed by the majority vote of the Annual Meeting. The proposed changes become part of the By-Laws by the affirmative vote of a simple majority of members responding by mail ballot by the deadline stated on the ballot.

Ballots will be prepared, distributed, and tallied by the Executive Board or it delegate(s).

b. serve as Chair of the Nominating Committee.

The Past President shall:

a. serve as a voting member of the Executive Board.

b. serve as a member of the Nomination Committee.

The Vice President-Programs shall:

c. serve as a voting member of the Executive Board.

The Secretary shall:

a. be responsible for the official correspondence to the Association.

b. keep accurate permanent records of meetings of the Association and the Executive Board.

c. serve as a voting member of the Executive Board.

The Treasurer shall:

a. be in charge of records and funds of the Association.

b. be in charge of all receipts and disbursements of the Association and keep accurate records of the same.

c. make a financial report at each regular business meeting.

d. make an annual report, audited by a supervisory committee at the regular meeting.

e. keep an up-to-date file and mailing list of members and potential members.

f. serve as a voting member of the Executive Board.

The Newsletter Editor shall:

a. create and distribute at least one edition of a newsletter each year.

b. notify members of Association meetings through the newsletter.

c. serve as a voting member of the Executive Board.

The Webmaster shall:

a. design, establish and maintain the official website for the Association.

b. serve as a voting member of the Executive Board.

The Membership Services Coordinator shall:

a. assist the President with plans to retain and increase the membership of the Association.

b. produce and present materials associated with the lifetime membership at the regular business meeting.

c. serve as a voting member of the Executive Board.

Article 3 – Election Procedures

The nominating committee shall consist of the President-Elect (chair), the Past President, and two members appointed by the current President. The nominating committee shall select a slate of nominees for each office. Anyone desiring nomination for an office shall notify the Chair of the nominating committee in writing at least three months prior to the Annual Meeting. The election will take place at the Annual Meeting. After taking nominations from the floor, a vote will be called for each office. The nominee receiving the plurality of votes from members present will be elected to office.

Article 4 – Amendment of the By-Laws

Amendments to the By-Laws may be presented by the membership and accepted as a proposal by a simple majority vote of members in attendance at the Annual Meeting. Notification of the proposed changes to the By-Laws will be communicated in the newsletter or other official means of communication. Ratification shall require a simple majority vote of approval by members in attendance at the subsequent Annual Meeting.
